EXCHANGE PROGRAM RULES AND PROCEDURES

- 1. Only units submitted by affiliated resort members/owners in good standing are available for this member to member / owner to owner exchange program. Confirmed exchanges are based on sleeping capacity; however, if you want to request a lower sleeping capacity to increase your chance for a confirmed exchange, that will be acceptable.
- 2. Units for rent and units offered for sale by the marketing company are not available to participate in the exchange program.
- 3. The exchange program is fully automated through a propriety computer system on a first come first serve basis. In some cases exchanges requested during holidays and other high season periods will be more difficult to confirm.
- 4. Unit location is not a priority; a beachfront unit may be confirmed into an off-beach unit. Unit assignment can not be guaranteed.
- 5. Exchange requests may be submitted a minimum of 75 days prior to the interval/week requested or the interval/week owned, whichever occurs first and a maximum of 12 months from the date the request is submitted. Interval Servicing will acknowledge receipt of the exchange request via e-mail. Seventy-five (75) days prior to the interval/week date requested or the interval/week owned, whichever occurs first, all pending unconfirmed requests will be cancelled.
- 6. For exchanges entered via the website (www.intervalservicing.com) the fee is \$149 US Dollars. Once an exchange is confirmed the fee is non-refundable. **NOTE:** The current exchange fee is \$179.00 U.S. Dollars if received by fax or mail.
- 7. Once an exchange is confirmed the trade is **FINAL**. You may cancel an exchange only <u>prior</u> to a confirmed exchange. A confirmed exchange cannot be cancelled as subsequent confirmed exchanges would be affected.
- 8. Exchanges may not be rented or externally exchanged.
- 9. Should the confirmed exchange become inconvenient, a new exchange (re-trade) request may be submitted with an additional exchange fee (applicable fee applies) using the confirmed exchange as the offered unit. Re-trades can be found via the website: www.intervalservicing.com
- 10. Exchanges will only be considered when the club service fee/maintenance fees and membership payments are current. If you are confirmed for an exchange and have not been billed for your club service fee/maintenance fee; you will be contacted by an Interval Servicing representative to assist you in collecting the fee. Once paid, this will finalize your exchange confirmation.
- 11. Exchange requests cannot be processed if the unit is in any of the following programs: (a) any rental program, (b) any resale program, (c) any other exchange program including but not limited to Interval International (I.I.) or Resort Condominiums International (R.C.I.).
- 12. PLEASE TAKE THE EXCHANGE CONFIRMATION PAPERWORK TO THE RESORT AS THIS WILL EXPEDITE CHECK-IN.

The fee for submitting an online request via www.intervalservicing.com is \$149.00.

The fee for submitting your form via fax or postal mail is \$179.00.
